
#### Gerardo Bello


# Mariana Vázquez del Mercado


# Pablo Guerrero V

At the age of 25, Pedro was selected to join the Council of Elders, and from this position he led the opposition of the Rapa Nui people against the construction of a hotel in Anakena. This opposition was because this place is an archeological and patrimonial area with significant importance to this ethnic group. In 1987, he participated in a sustained protest against of the construction of a 20 meters high lighthouse in front of the Rano Kau volcano, a project that would have introduced pollution of light directly onto the Orongo village that is not just a Rapa Nui community, but is also a World Heritage site. As Mayor, he strives to educate his community on human rights. He has appeared before international courts and tribunals worldwide to represent his community on topics such as historical oppression and the restitution of lands and cultural symbols.
