The Importance of Mentoring

While women graduate from law schools and take positions at entry level in equal number to men, top leadership positions remain a male bastion. The ability to retain female talent has not yet been sufficiently mastered. Law firms are increasingly concerned with the "leaking pipeline", since attracting, developing and promoting best talent is essential to keep a competitive edge. Understanding the reasons behind the current gender gap is crucial to devise effective gender diversity policies. Unless we address the root causes, the number of women in leadership positions will remain low.

The Vance Center has been committed to the advancement of women in the legal profession in Latin America since 2007. We are proud to have been the first to sponsor conferences that have brought together women leaders and younger professionals in the legal profession to discuss gender issues in the workplace. We have been instrumental to the creation of a strong network among women lawyers in Latin America, many of whom will be present at the conference, and have sparked several successful gender initiatives in the region.

Abundant literature has singled out certain feminine common traits that result from culture, upbringing, social and working habits, which make it more difficult for women to navigate the system. At the same time, in a knowledge economy, other traits traditionally associated with women, such as empathy and team work, are particularly valued in present times. As relative newcomers to the working world, designed by and for men, the importance of mentoring to help women lawyers overcome hurdles cannot be sufficiently underscored.

During this conference we will briefly review some of the traits that have been identified as typically feminine, which make it more difficult for women to climb the ladder, as well as those that are advantageous, as a preamble to discussing the advantages of mentoring.

Mentoring programs are aimed at overcoming traits that hold one back, teaching new skills, improving communications, bridging generation gaps and developing leadership abilities. After reviewing a pioneer mentoring program established in Mexico, we will split into discussion tables with moderators to collect input from the audience and discuss best practices for the implementation of successful mentoring programs.

We are confident that this conference will be a new landmark on the road on which the Vance Center embarked in 2007.


Biographies of Presenters and Moderators



Antonia Stolper, Partner Shearman & Sterling LLP, Vice Chair Cyrus R. Vance Center for International Justice

Antonia Stolper is the Latin America Regional Managing Partner and a member of Shearman & Sterling's Capital Markets-Americas practice group. Ms. Stolper's practice focuses primarily on corporate finance transactions in emerging markets. She has extensive registered public offering experience for foreign private issuers. Her practice focuses on debt and equity securities offerings for Latin American corporate and sovereign issuers, representing both underwriters and issuers, and on restructuring transactions in Latin America, representing issuers, dealer managers and creditors. As Honeywell International Inc.'s Vice President & General Counsel for Latin America, Valeria provides general commercial, corporate governance and compliance advice to Honeywell's operations in LATAM with over 19,000 employees in Argentina, Brazil, Chile, Colombia, Costa Rica, Mexico, Panama, Peru, Venezuela and Uruguay. The LATAM Law Department she leads is currently formed by 12 legal and contracts managers based in Mexico and Brazil. Before joining Honeywell, Valeria was a partner at Baker & McKenzie based in Monterrey, Mexico. She also worked at the firm's New York (2004) and Mexico City (2006-2008) offices. She holds a JD from the Universidad de Monterrey, Mexico (Cum Laude, 2001) and a Master of Laws (Harlan Stone Fiske Scholar, 2004) from Columbia University in New York.

In 2015, Valeria co-founded an NGO formed by Mexican in-house and law firm attorneys called Abogadas MX, which aims to increase the representation of women in leadership positions through initiatives that promote networking, professional development and leadership opportunities for women attorneys. Through this NGO, Valeria launched an innovative mentoring program in Mexico that pairs senior lawyers from corporations and law firms with junior lawyers to guide their professional growth and share best practices. Valeria is a 2013 Fellow of the Leadership Council on Legal Diversity (LCLD) and an active supporter of the Women in the Profession initiative led by the Cyrus R. Vance Center for International Justice of the New York City Bar.





Carrie H. Cohen, Office of U.S. Attorney for Southern District of New York

Ms. Cohen works for the U.S. Department of Justice as an Assistant U.S. Attorney in the Southern District of New York, Criminal Division, where she prosecutes public corruption, white collar fraud, and narcotics cases. Most recently, Ms. Cohen was the lead prosecutor in United States v. Sheldon Silver, which was a bribery, extortion, and money laundering criminal prosecution of the former longtime Speaker of the New York State Assembly that resulted in guilty verdicts on all counts. Previously, Ms. Cohen was Chief of the Public Integrity Unit in the New York State Attorney General's Office and an Assistant Attorney General in the Civil Rights Bureau. Ms. Cohen also was a litigation associate at Morrison & Foerster and at Vladeck, Waldman, Elias & Engelhard, where she specialized in representing women in the workplace. In 2002, Ms. Cohen and her family lived in Bhutan where she was a consultant to the Chief Justice and drafted the country's Penal Code and Rules of Evidence. Ms. Cohen is active in bar associations, having served as Vice President of the New York City Bar, Chair of the New York City Bar's Executive Committee, Chair of the Commercial and Federal Litigation Section of the New York State Bar Association, and Member of the House of Delegates of the New York State Bar Association. Ms. Cohen also is a member of the American Inn of Court, Federal Bar Council, Chair of the Board of Directors of CITYarts, Inc., and an appointed member of Cornell University's President's Council of Cornell Women. In addition, Ms. Cohen is on the advisory committee of the Cyrus R. Vance Center for International Justice on whose behalf she has helped organize and spoken at conferences throughout Latin America regarding the advancement of women attorneys. Ms. Cohen earned her J.D. from the University of Pennsylvania Law School and her B.A. from Cornell University. Ms. Cohen lives with her husband and four children in New York City.
