Vance Center Environment Program Director Speaks at Princeton Conference



On February 7, Vance Center Environment Program Director, Susan Kath, spoke on a panel, *Climate Change, Global Health and Human Rights*, sponsored by Princeton University's Program in Global Health and Health Policy. The program, organized in conjunction with Princeton's Spring 2014 Global Health Colloquium, featured a talk by Dr. Marcos A. Orellana, Director of the Environmental Health Program at the Center for International Environmental Law (CIEL). In his talk, Dr. Orellana discussed the global implications that climate change has for the extraterritorial obligations of actors in a statecentered system and how a human rights-based approach should be used to address the global health impacts of disease and disasters caused by climate change. Ms. Kath's presentation described her experience litigating climate change cases and the Vance Center's work for John Knox, the UN Independent Expert on Human Rights and the **Environment**. She shared how that research, based on global and regional sources, points towards the human rights obligations that potentially arise in connection with climate change and the protection of vulnerable groups, including women, children and indigenous peoples. Joining Ms. Kath on the panel were Joe Amon, Director of the Health and Human Rights Division, Human Rights Watch, and Adrianna Petryna, Edmund J. and Louise W. Kahn Professor in Anthropology, University of Pennsylvania.

- A Latin American NGO striving to secure clean water for indigenous and Afrodescendent communities;
- An African NGO advocating for disclosure of state information, based on the experience of truth commissions in various countries;
- A Latin American NGO taking a free expression case to the UN Human Rights Committee;
- An international strategic litigation NGO pursuing release of government information related to public security investigations in Latin America;
- An African NGO challenging proposed legislation restricting women's property rights, based on international and comparative standards;
- An international conservation NGO analyzing carbon validation and verification standards in a Latin American country.

Vance Center Hosts Argentine Fulbright Scholar



The Vance Center over the past year has hosted **Mariela Aisenstein**, a Fulbright visiting scholar from Argentina. Her research has assessed the effectiveness of public-interest litigation in Argentina and the United States in expanding the access to health care, education, and adequate housing. A graduate of Universidad Torcuato Di Tella in Argentina and Harvard Law School's LLM Program, Ms. Aisenstein developed the project after several years of litigating public-interest cases in Argentina, including at Asociación Civil por la Igualdad y la Justicia, Asociación por los Derechos Civiles, and the Public Defender's Office of Buenos Aires. Ms. Aisenstein's research seeks to help policymakers in Latin America and the United States develop ways of strengthening implementation of courts' decisions in public interest cases. Referring to cases which she helped to bring in Argentina, Ms. Aisenstein observed that "[i]f implemented, the decisions would have significantly increased access for poor people to public services. Too often, however, the government did not comply with the courts' orders, either because it lacked the will or wherewithal to do so or because the decisions had failed to

set up effective mechanisms for implementation."

Vance Center South African Legal Fellows Program Launches New Year

The Vance Center's **South African Legal Fellows Program** places South African lawyers from disadvantaged backgrounds with corporate law firms and corporate legal departments in New York City for one-year terms. The Vance Center is currently seeking applications from qualified lawyers for the 2014-15 term, which will begin in or around September 2014. Applicants must have at least two years of corporate-law experience in order to apply.
