

Ambassador Mari Carmen Aponte Mari Carmen Aponte served as Acting Assistant Secretary in the Department of State's Bureau of Western Hemisphere Affairs from May 2016 until January 2017. Previously, Aponte was the Ambassador of the United States to El Salvador since 2012. Her priorities in El Salvador included expanding crime prevention, growing the economy and moving the country towards democracy, sustainable development and human rights.

She is the first Puerto Rican woman to hold the title of ambassador. Born in Puerto Rico, Aponte moved to the United States to pursue a better education. After earning a B.A. in political science from Rosemont College, she taught in Camden, New Jersey, and became aware of underrepresented educational needs of minority students. Aponte enrolled in Temple University Beasley School of Law and earned a J.D. in 1975. She was one of few Puerto Rican women enrolled in a U.S. accredited law program at that time and, subsequently, the first Latina lawyer in Pennsylvania. Aponte moved to Washington, D.C., in 1979 when President Jimmy Carter appointed her a White House Fellow. She continued practicing law in D.C. and co-founded one of the first minority-owned law firms. In 1984, Aponte was elected the first woman president of the Hispanic National Bar Association. She continued to hold leadership positions for the next 25 years, advocating for women and the Latino community. From 2001-2004, she was Executive Director of the Puerto Rican Federal Affairs Administration. She was also on the board of directors for the National Council of La Raza and the Puerto Rican Legal Defense and Education Fund, and later provided strategic counsel for the Hispanic Information and Telecommunications Network, a Spanishspeaking national non-commercial television network. Aponte received the 2015 Margaret Brent Women Lawyers of Achievement Award from the American Bar Association in recognition of her community service.





Carmen Román Arancibia

Corporate General Counsel and Head of Corporate Affairs, Walmart Chile Carmen Román Arancibia, lawyer from the Universidad Gabriela Mistral of Chile, has more than 18 years of experience in the retail area. She has worked since 1999 in a Chilean supermarkets chain owned by the Dutch multinational company Ahold. In 2004 she was contracted by the Chilean retail company Cencosud as a Corporate General Counsel, and actively participated in the international process of the expansion of the Chilean group in South America. She specializes in acquisitions, company mergers and the corporate area. Since December of 2009, she has worked in Walmart Chile S.A., as Corporate General Counsel.

During the first four years the in the company she was responsible for the development and implementation of the Ethics and Compliance program. Since 2016, she has also been responsible for Corporate Affairs.

In 2015 she was elected counselor of SOFOFA, an influential business Chilean association and since 2015 has been part of the business executive committee.

She has been named as one of the top 100 female leaders of the country, recognized by peers and professionals from other areas of Chilean business.





Patricia López Aufranc has been a partner of Marval, O'Farrell & Mairal since 1987, specializing in corporate, banking and international trade.

Her practice has focused on transnational financial and commercial transactions, including debt and equity issues, syndicated loans, derivatives, investment funds and asset securitizations. She also advises clients on transborder mergers and acquisitions, joint ventures, dumping investigations and a wide range of business contracts.

Before joining the firm she worked for The First National Bank of Boston. She also worked for the firm of Klein & Mairal and for the Office Juridique Français et International in Paris.

She graduated from the Law School of the University of Buenos Aires in 1975 and obtained a Diplôme Supérieur in Corporate Law from the School of Law, University of Paris II in 1977. She received a Master in Laws from Harvard University in 1985. During 2015 she was a Fellow at Harvard's Advanced Leadership Initiative along with 40 other professionals from different countries and practice areas.

She has published numerous articles in Argentina and abroad, and regularly makes presentations in her areas of practice.

She chaired the Corporate Law Commission of the International Association of Lawyers ("UIA"), and is Deputy of the Rule of Law Section UIA-IROL to the UIA Executive Committee.

She sits on the board of the Harvard Law School Women Alliance, is an International Member of the Harvard Alumni Association's Council, and a board member of the Harvard Club of Argentina.

She is a member of the Executive Committee of Women in the Profession, at the Cyrus Vance Center for International Justice, New York.

Patricia was one of the founders and former chair of the Argentine Forum of Executive Women (FAME).

She has been identified as leading lawyer in banking, capital markets and international trade by Euromoney Publications, Chambers, Global Counsel 3000 and Latin Lawyer.

She was singled out as leader of Mercosur by *Gazeta Mercantil* (Sao Paulo, 2000); as one of the 50 top women leaders in Argentina by *Apertura*, a leading business magazine in Argentina; and as a top women lawyer by *Latin Lawyer*. She was awarded the first edition of the Diversity Award by *Latin Lawyer* (2014) for her contribution to the advancement of women lawyers in the legal profession in Latin America.

The LATAM Law Department she leads has 18 legal and contracts managers based in Mexico, Brazil, and Argentina. Before joining Honeywell, Valeria was a partner at Baker McKenzie in Monterrey, Mexico. She also worked at the firm's New York (2004) and Mexico City (2006-2008) offices. She holds a J.D. from the Universidad de Monterrey, Mexico (Cum Laude, 2001) and a Master of Laws (Harlan Stone Fiske Scholar, 2004) from Columbia University in New York.

In 2015, Valeria co-founded an NGO with Mexican in-house and law firm attorneys called Abogadas MX, which aims to increase the representation of women in leadership positions through initiatives that promote networking, professional development and leadership opportunities for women attorneys. Through this NGO, Valeria launched an innovative mentoring program in Mexico that pairs senior lawyers from corporations and law firms with junior lawyers to guide their professional growth and share best practices. Valeria is a 2013 Fellow of the Leadership Council on Legal Diversity (LCLD) and an active supporter of the Women in the Profession initiative led by the Cyrus R. Vance Center for International Justice of the New York City Bar.







Judy Hargrave has been Assistant General Counsel for Philip Morris International's Latin America and Canada region since 2011.

She joined Philip Morris International in 1988 as a Corporate Counsel for Philip Morris Limited (Australia), having started her in-house counsel career at Hoechst (Australia) Ltd in 1986. 

She organizes the annual conferences across Latin America that the Vance Center has convened since 2007, bringing together women leaders and younger legal professionals to discuss gender issues in the workplace. These conferences have sparked several successful gender initiatives in the region, such as Mexico's mentoring program, now being replicated regionally.

Adriana also directs other Vance Center key initiatives among lawyers, law firms and civil society in Latin America, including the newly-established Lawyers Council for Civil and Economic Rights in the Americas. She also provides support to the Vance Center's efforts to promote pro bono practice in Central America and other countries in the region.

Prior to joining the Vance Center, Adriana worked as an associate and Of Counsel with the law firm Shearman & Sterling on general corporate and banking finance transactions. She also served as a member of the Greenwich Board of Education in Greenwich, Conn., where she volunteered for a not-for-profit organization serving children and adults with disabilities.

Claudia F. Prado is the Chair for Latin America for Baker McKenzie, the first woman in the firm's history to hold this position. She is a member of the Global Executive Committee and chairs the Diversity and Inclusion and Finance Committees of the firm at the global level.

She has developed a successful career as a Mergers and Acquisitions specialist, starting in Brazil at Trench Rossi Watanabe, which has a cooperation agreement with Baker McKenzie. 




